You are encouraged to integrate other funding sources, including memorial funds, keeping in mind that the congregation is more likely to pray for, speak of and participate in a ministry if they are "invested," with time and energy as well as funds.
- C. How is your group planning to involve the congregation in this ministry?
- D. Include a statement of impact and intent: How might Grace UMC be different 3 to 5 years from now if your group is encouraged by receipt of these monies?
- E. If you have previously requested and received funds for the same ministry for which you are now applying, provide some history of your attempts and tell how this request is different and/or timely.
- F. If this project may not be self-funding after this two-year funding cycle, tell how you intend to continue or perpetuate beyond the two years.
- G. Preference will be given to applications submitted by ministry teams or committees; then by groups of people; lastly by individuals. If an individual's request is related to a current ministry area, please coordinate with their leadership prior to submission.
- H. All requests must include the signature of at least one member of GUMC.
- I. Foundation monies are not to be used for costs normally included in the Ministry Funding Plan of the church.
